## ACCESSING SMALL BUSINESS ADMINISTRATION LOAN PROGRAMS

On Monday, April 27 at 7:30am Pacific Time the Payroll Protection Program (PPP) and Economic Injury Disaster Loan (EIDL) programs will go live. Funds are not anticipated to last long so businesses should prepare now and apply as soon as possible.

- For a PPP loan apply directly to a bank or approved lender. If you don't have a banking relationship already, you can contact [banks listed in an SBA tool](#). Manufacture: San Jose, a nonprofit partner, has compiled some [information on SBA-approved PPP lenders](#) in the Bay Area.
- To apply [for an EIDL loan, go directly to the SBA](#).
